Sir/Madam,

Index Homoeopathic Medical College has submitted an application for admission in BHMS course with intake capacity of 100 seats for the academic year 2026-27. The Medical Assessment and Rating Board (MARBH) has examined Standard application Proforma submitted by the college, followed by inspection on 01.04.2026 & 02.04.2026 & hearing on 11.05.2026. MARBH has examined the College to ascertain whether the college fulfils the Minimum Essential Standards as per the regulations in force. On careful examination of the report, MARBH observed the following shortfalls:

A. In Department of METU: Book and Journals are not available.

2. Considering the observations during examination of inspection report & hearing, MARBH has decided to issue **Conditional Permission to Index Homoeopathic Medical College, Hospital & Research Centre, Index City, Gram Morodhat, NH-59 A, Nemawar Road, Indore, Madhya Pradesh- 452016 for admission in BHMS course with intake capacity of 100 seats for the academic year 2026-27** on the basis of following conditions:

- i. College should make available Book and Journals in Department of METU as per sub regulation C(2) of First schedule of National Commission for Homoeopathy (Minimum Essential Standards for Homoeopathic Colleges and Attached Hospitals) Regulations, 2024.

Deficiency mentioned above should be rectified within a period of 30 days and the compliance report must be submitted to the undersigned, failing which conditional permission issued will be withdrawn without further notice.

3. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of UG seats shall be treated as All India Quota. Counselling for seats under all India Quota shall be conducted by respective Counselling Authority of State/UT Government as designated by Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the State/UT Government.
4. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
