

l am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 20/03/2018 considered the Compliance Verification Assessment Report (05/02/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 30/10/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification against increased intake from 03 to 09 seats at Index Medical College Hospital & Research Centre, Indore granted by Madhya Pradesh Medical Science University, Jabalpur and decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05/02/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 30/10/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Pathology) qualification against increased intake from 03 to 09 seats granted by Madhya Pradesh Medical Science University, Jabalpur in respect of students being trained at Index Medical College Hospital & Research Centre, Indore be recognized and included in the 1st Schedule to the I.M.C.
